SUBMISSION NO. A31/21**

**TAKE NOTICE** that an application has been received from **Hymask Roofing, c/o Mark Hyatt on behalf of Roger and Paula Hanlon** for a minor variance from Zoning By-law 2009-141, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

**IN THE MATTER OF** the premises described as PLAN 30 PT LOT 29 RP 51R42441 and known municipally as **23 Caroline Street** in the City of Barrie.

This property is zoned Residential Multiple Dwelling First Density – Special Provision 528-HC (RM1) (SP-528-HC).

This application, if granted by the Committee of Adjustment, will serve to permit a deficient lot area, lot frontage and side yard setback to facilitate the construction of a proposed single detached dwelling.

The applicant is seeking the following minor variance(s):

1. **A lot area of 426.60 square metres, whereas the Comprehensive Zoning By-law 2009-141, under Section 5.3.1 Table 5.3 requires a minimum lot area of 600 square metres.**
2. **A lot frontage of 9.14 metres, whereas the Comprehensive Zoning By-law 2009-141, under Section 5.3.1 Table 5.3 requires a minimum lot frontage of 18 metres.**
3. **A side yard setback of 1.2 metres, whereas the Comprehensive Zoning By-law 2009-141, under subsection 5.3.3.2(b), requires a minimum side yard setback of 3 metres.**

The subject application is being considered concurrently with applications B10/21 and A37/21.

**TAKE FURTHER NOTICE** that the Committee of Adjustment public hearing has been scheduled for **Wednesday, June 23, 2021**. With the current restrictions on public gatherings due to COVID-19, this public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM**.

Notices are sent to all property owners shown on the last assessment records within 60m of the subject property.

Although this is a public hearing, you are not required to attend unless you wish to speak to the application. If you have specific comments regarding this application, you may submit comments to the Secretary-Treasurer of the Committee of Adjustment at [cofa@barrie.ca](mailto:cofa@barrie.ca).

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence and you will receive no further notice. You must register and attend the hearing to receive further notice.

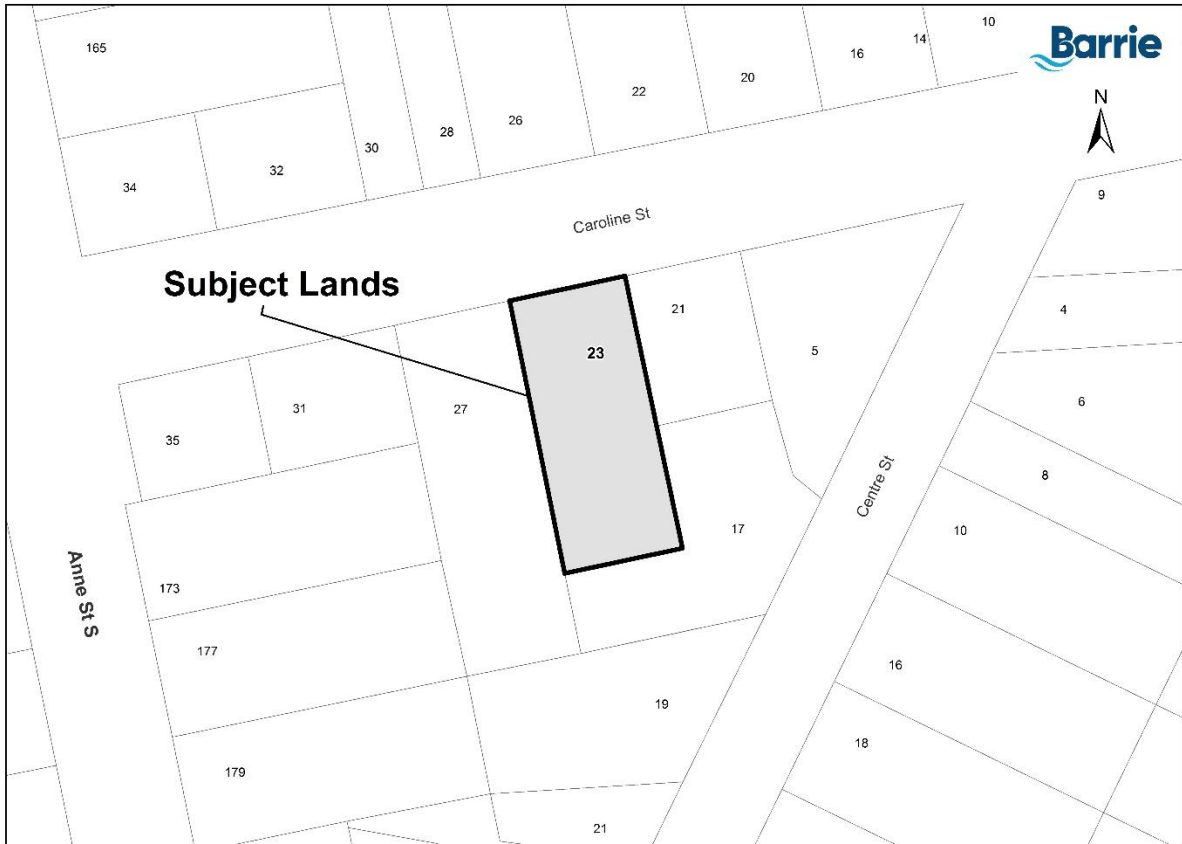
