TAKE NOTICE that an application has been received from **Baldwin Planning and Development Consultants c/o Angela Baldwin on behalf of Dunlop-Ferndale Inc. c/o Bill Greenfield** for a minor variance from Zoning By-law 2009-141, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

IN THE MATTER OF the premises described as PLAN 51M199 PT LOT 1 and known municipally as **440 Dunlop Street West** in the City of Barrie.

This property is zoned General Commercial (C4) and Light Industrial (LI).

This application, if granted by the Committee of Adjustment, will serve to permit exceeding the maximum allowable height to facilitate the construction of a 6-storey hotel.

The applicant is seeking the following minor variance(s):

- 1. A building height of 19.8 metres, whereas the Comprehensive Zoning By-law 2009-141, under Section 7.3.1 Table 7.3, permits a maximum building height of 14 metres.**

The subject application is being considered concurrently with applications B4/22, B5/22, B7/22, B8/22, B10/22, and B11/22.

TAKE FURTHER NOTICE that the Committee of Adjustment public hearing has been scheduled for **Wednesday, April 27, 2022**. With the current restrictions on public gatherings due to COVID-19, this public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM**.

To participate in the virtual planning meeting, you will need access to a computer with internet service or a telephone. For information on how to register for the meeting please go to: www.barrie.ca/cofa.

Notices are sent to all property owners shown on the last assessment records within 60m of the subject property.

Although this is a public hearing, you are not required to attend unless you wish to speak to the application. If you have specific comments regarding this application, you may submit comments to the Secretary-Treasurer of the Committee of Adjustment at cofa@barrie.ca.

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence and you will receive no further notice. You must register and attend the hearing to receive further notice.

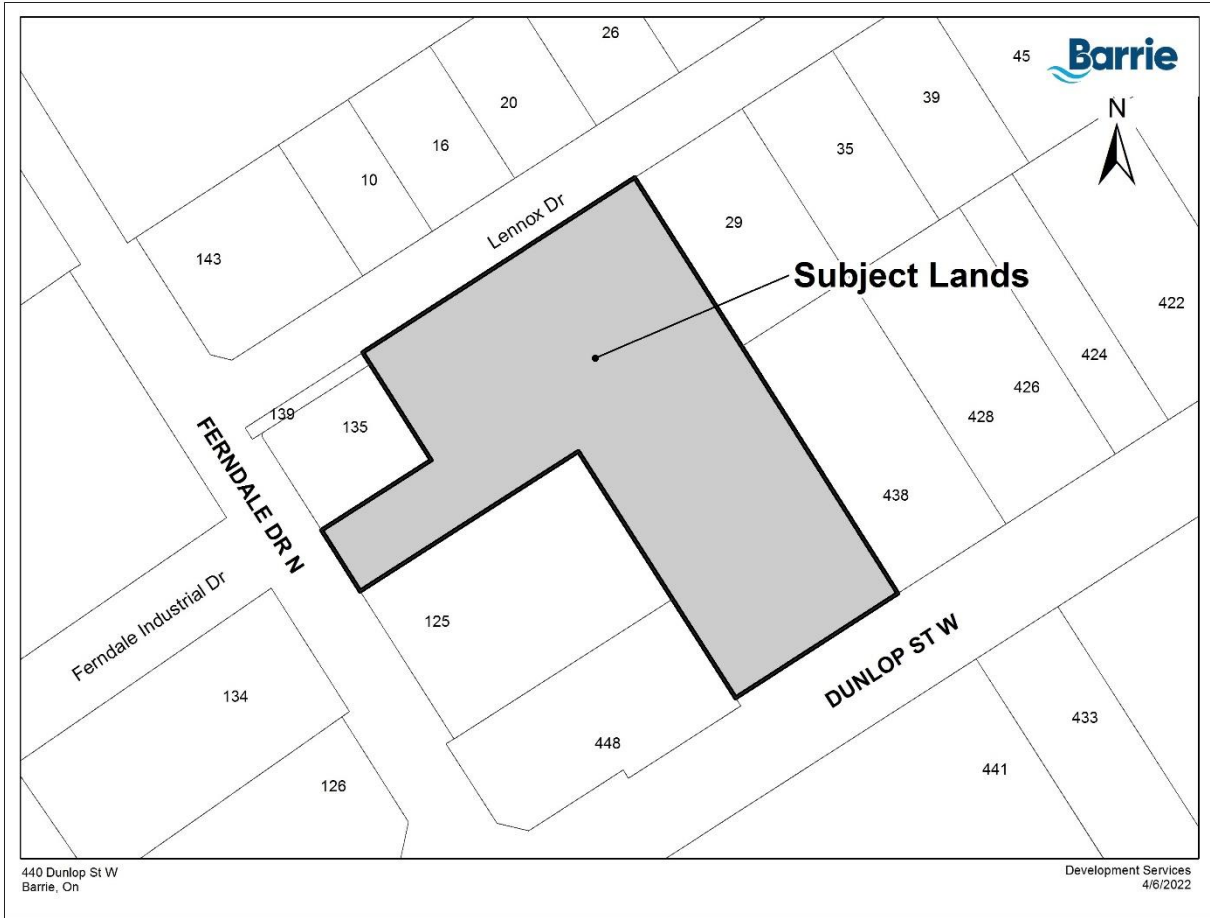
