TAKE NOTICE that an application has been received from **Baldwin Planning and Development Consultants c/o Angela Baldwin on behalf of Dunlop-Ferndale Inc. c/o Bill Greenfield** for consent under Section 53 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended for a consent to a conveyance of property for commercial purposes.

IN THE MATTER OF the premises described as CON 6 VESPRA W PT LOT 24 RP 51R3192 PT PART 2 and known municipally as **125 Ferndale Drive North** in the City of Barrie.

The property is zoned General Commercial (C4).

The application, if granted by the Committee of Adjustment, will serve to permit the creation of a new commercial lot.

The severed lands propose to have a lot area of 1,768 square metres and a proposed lot frontage of 21.37 metres on Ferndale Drive North.

The retained lands propose to have a lot area of 3,629 square metres and a proposed lot frontage of 53.71 metres on Ferndale Drive North.

The subject application is being considered concurrently with applications B4/22, B5/22, B8/22, B10/22, B11/22 and A7/22.

TAKE FURTHER NOTICE that the Committee of Adjustment public hearing has been scheduled for **Wednesday, April 27, 2022**. With the current restrictions on public gatherings due to COVID-19, this public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM**.

To participate in the virtual planning meeting, you will need access to a computer with internet service or a telephone. For information on how to register for the meeting please go to: www.barrie.ca/cofa.

Notices are sent to all property owners shown on the last assessment records within 60m of the subject property.

Although this is a public hearing, you are not required to attend unless you wish to speak to the application. If you have specific comments regarding this application, you may submit comments to the Secretary-Treasurer of the Committee of Adjustment at cofa@barrie.ca.

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence and you will receive no further notice. You must register and attend the hearing to receive further notice.

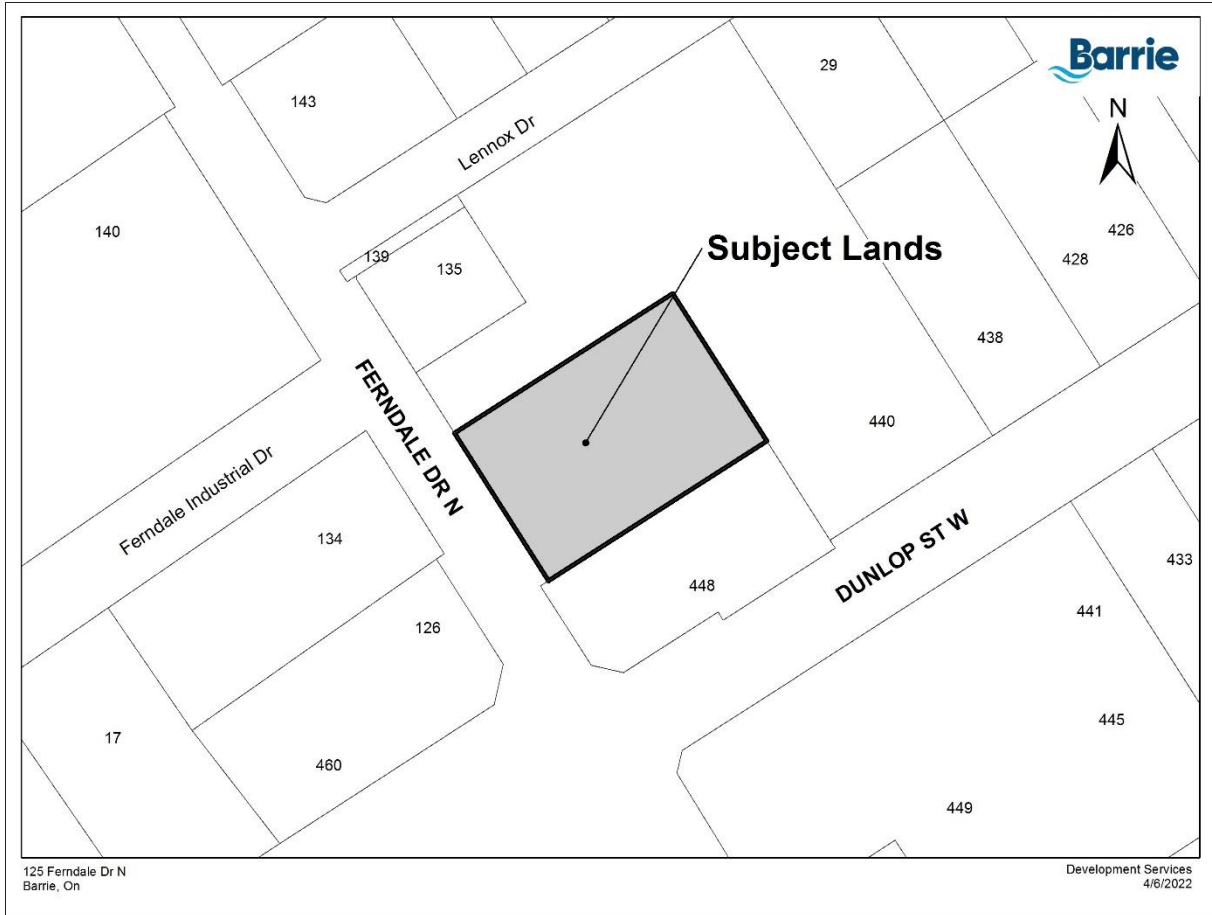

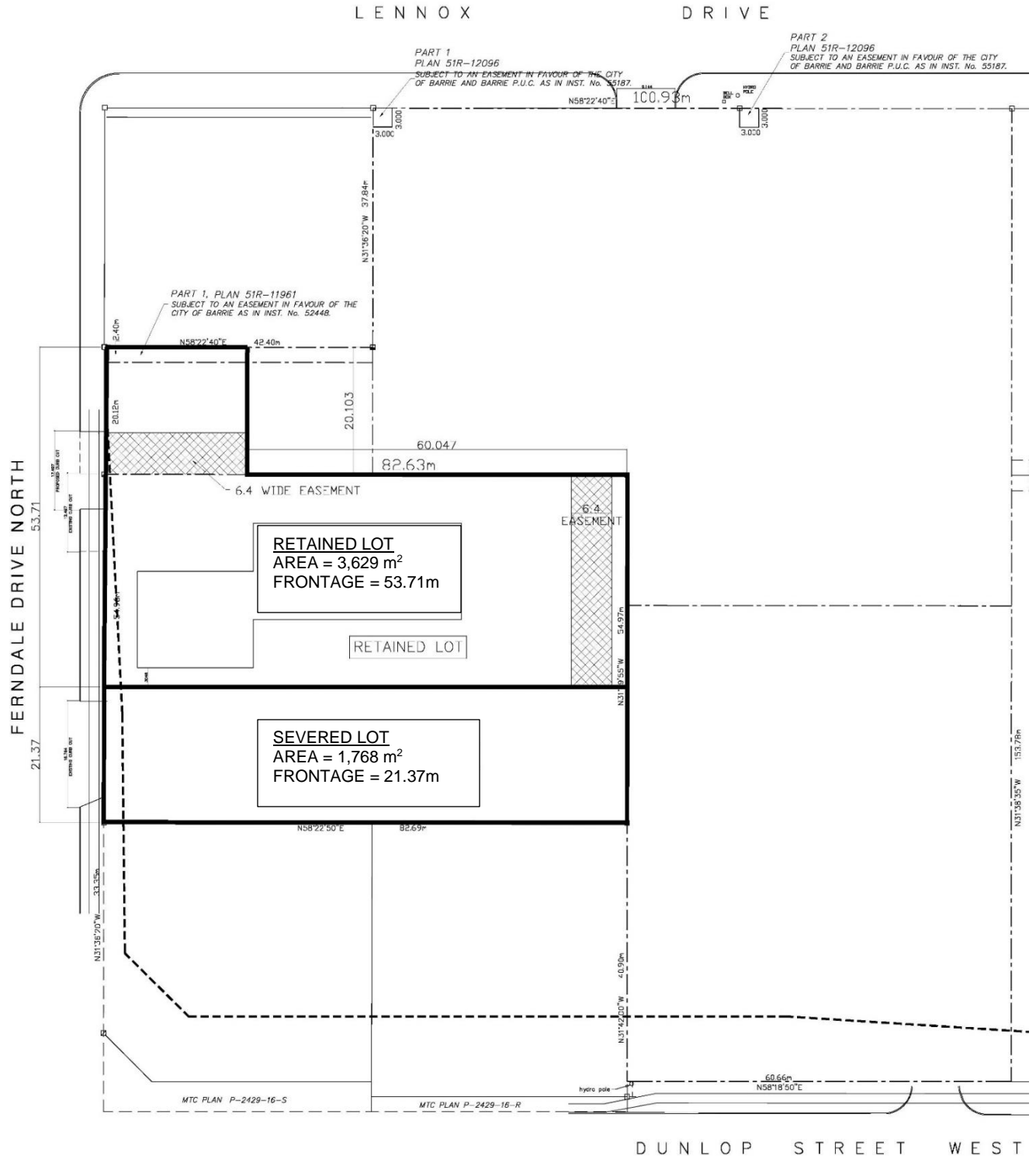
