



## Barrie Transit Student Photo Identification Card Application

### Criteria

- To be eligible for a Barrie Transit **Student Photo** ID Card – Grades 8 to 12, a Student must meet all the following criteria:
  - 13 to 21 years of age (inclusive);
  - Attend classes full time at a public or private school between the grades 8 to 12 (inclusive) in the Barrie Transit region.
  
- To be eligible for a Barrie Transit **Post-Secondary** Student Photo ID Card, a Student must meet all the following criteria:
  - Students must be registered in a full time recognized educational program with an accredited school or institution as recognized by the Post-secondary Education Choice and Excellence Act, 2000
  - Enrolled in a full-time degree, diploma or certificate program in a recognized Post-Secondary institution.
  - Enrolled as a full-time student at a Private Career College.
  - Proof of full-time enrollment as a post-secondary student in a recognized Post-Secondary program, must be presented when obtaining your Photo ID.
  - One piece of Photo ID will be required to validate application and obtain Barrie Transit Post-Secondary Transit ID.
  
- To be eligible for a Barrie Transit Student Photo ID Card for **Social Programming**, a Student must meet all the following criteria:
  - Attend classes full time at a public or private School/Institution in the Barrie Transit region.
  
- ✓ This Application **must be completed in full** and certified by your school administration office. Only original copies of this application form will be accepted. We may contact your School Administration Office to verify the information provided within the application.
  
- ✓ The Barrie Transit Photo Identification Card will be confiscated without refund if the information on this application has been falsified.
  
- ✓ The Barrie Transit Photo Identification Card must be presented upon boarding with the appropriate ride card or pass to the Transit Operator in an open and unrestricted manner.
  
- ✓ Please bring this completed application form for your Photo ID, to the Ticket Sales Counter at the Barrie Transit Terminal, 24 Maple Ave. Photo ID Cards are \$5.00.
  
- ✓ Barrie Transit Photo ID Cards are valid until the end of the school year or the expiry date of the educational program or one year from date of purchase, if not identified on the application.
