

IMPORTANT PAYMENT INFORMATION

Most Provincial Offences fine payments can be made on line at www.paytickets.ca by VISA or MasterCard.

In order to process your mailed in payment (cheques or money orders), our office will require the following information included with your payment:

Name: of person charged
 Current Address: of person charged
 File Number: located on top of your ticket; top left hand corner of your trial notice; or on your Notice of Fine and Due Date

***Payments must be made payable to: the City of Barrie.**

Payments for file numbers starting with 3860 must be mailed to City of Barrie Court Services, 45 Cedar Pointe, Barrie, ON, L4N 7R5.

Payments for file numbers starting with 3861 must be mailed to City of Barrie Court Services, 575 West Street, South, Unit #10, Orillia, ON, L3V 7N6.

Payments are also accepted in person at any Provincial Offences Office in the Province of Ontario by VISA, MasterCard, debit and cash.

In addition to court ordered fines a Victim Fine Surcharge is also applicable Ontario Regulation 161/00. Please see the chart below for an explanation as to how the Victim Fine Surcharge is applied.

In addition to the Victim Fine Surcharge, additional costs are applied by Ontario Regulation 945. Please see the chart below for an explanation as to what additional costs are applied.

The following costs are payable upon conviction for the purposes of subsection 60 (1) of the Act:

1.	For service of offence notice or summons	\$5.00	5.	Upon conviction under subsection 18.2 (6) of the Act	\$16.00
2.	Upon conviction under section 9 of the Act	\$5.00	6.	Upon conviction under section 18.4 of the Act	\$12.75
