**TERMS OF AGREEMENT: COLD WEATHER HYDRANT EXTENDED USE PERMIT**

This form is intended to be used in accompaniment with *F15-16 Hydrant Extended Use Permit*, for instances when a hydrant metered gate valve is requested for use during cold weather, and low temperatures may cause freezing. The undersigned applicant is required to meet the following conditions, in addition to all obligations outlined and agreed to in form *F15-16 Hydrant Extended Use Permit*.

**CONDITIONS OF SERVICE:** **NOTE: Applicant/contractor is not permitted to operate the fire hydrant at any time.**

1. The applicant is responsible for the protection from cold weather of both the hydrant and all installed City of Barrie (“City”) equipment.
2. The applicant agrees to construct an insulated enclosure around the hydrant, of adequate size for the hydrant and all installed equipment, while ensuring the accessibility of the hydrant operating nut for operation by the Water Operations Branch (“WOB”) staff.
3. The applicant agrees to ensure the enclosure is situated in such a way not to hinder the accessibility of the hydrant secondary valve.
4. The applicant agrees to unambiguously indicate, on all sides of the enclosure, that there is a fire hydrant inside the enclosure, as per Barrie Fire & Emergency Service (“BFES”) requirements.
5. The applicant is responsible to provide an uninterrupted heat source to the enclosure to adequately prevent freezing or damage to the hydrant/equipment contained inside.
6. The applicant agrees to maintain safe and satisfactory access to the enclosure.
7. The applicant is responsible for any damages to the hydrant and/or City equipment due to freezing.

The applicant shall indemnify the City against all losses, expenses, penalties and legal costs it may incur from any injuries and damages suffered by any person or entity related to any activities or omissions committed by the applicant under this permit.

Charges for the installation and removal of equipment will be at current rates outlined in the City’s Fees By-law (as amended). Water shall be charged at the current maximum water rate per m<sup>3</sup>.
