

QUEENS PARK A1 NEIGHBOURHOOD RECONSTRUCTION PROGRAM

RE-START DATE: Spring 2025 END DATE: Spring 2026 Timeline is subject to change.

The City of Barrie ('City') Queens Park A1 Neighbourhood Reconstruction Program is being performed by Arnott Construction. Phase 1 was completed in December 2024, which included the reconstruction of Sophia Street West and Mary Street.

WORK UPDATE

Arnott Construction will continue progress on:

Maple Avenue by:

- Replacing the watermain and water services;
- Replacing sanitary sewers and services, storm sewers, catch basins, and maintenance holes;
- Replacing sidewalks, curbs, and disturbed driveways on the City boulevards;
- Installing new streetlights and poles;
- · Paving base asphalt; and
- Paving the top layer of asphalt in Spring 2026.

Wellington Street West by:

- Replacing the watermain;
- Replacing curbs and disturbed driveways on the City boulevards on the south side;
- · Paving base asphalt on the south side; and
- Paving the top layer of asphalt in Spring 2026.

Sophia Street West by:

- Installing new streetlights and poles; and
- Paving the top layer of asphalt in Spring 2026.

WHAT TO EXPECT

You may experience inconveniences such as dust, noise, and short delays. The City will make efforts to reduce impacts, and your patience is appreciated.

Further notice will be provided to property owners who are required to remove items, such as decorative objects, located within City property limits (boulevard).

If you have a sprinkler system within the boulevard portion of your property, please contact the City's representatives below. The City will not be responsible for damage to any privately owned items on City property, including sprinkler systems.

Road and Sidewalk Access:



Pedestrian access will be maintained during construction.

Maple Avenue and Mary Street will be closed to through traffic, with access to residences and business' being maintained. Wellington Street West will remain open with lane closures taking place throughout construction. The City will post signage, as required, on how to access businesses.

Access for emergency vehicles will always be maintained.

Driveway Access:



At times, direct access to driveways will be interrupted for driveway, sidewalk, curb replacement and, watermain and sanitary sewer work. Notice of driveway disruptions will be provided before they occur.

Services:



Hydro, telephone, cable TV, and gas services should not be affected by the construction, barring any unforeseen circumstances.

Water and sanitary sewer services will be interrupted for a short period of time. Advanced notice of the service interruptions will be provided.



Accessibility:

If you have any accessibility requirements, such as wheelchair access or home care, please contact the City representatives listed below.



Traffic Management:

The Contractor will use traffic control measures, such as traffic cones to steer through traffic around contractor equipment and vehicles, within the construction site. Flag persons will assist with traffic control, if required.



Parking:

Parking on roadways in an active construction area is not permitted. Vehicles parked in the construction zone will be ticketed and towed.



Garbage and Recycling:

Garbage, recycling, and yard waste will be collected on the regular collection day during construction. Arnott Construction may need to move items to a designated area for pickup by the City's waste contractor. Garbage cans, organics bins, and recycling boxes will be returned to your property later the same day. **Clearly mark your address on all containers**.

Ensure everything for pick up is curbside by 7:00 a.m. on the collection day or it may not be picked up.



Safety:

The Contractor is required to conduct work in a safe manner, such as using traffic cones and fencing off excavations. Please use extra caution in the construction zone to ensure everyone's safety.

The City would like to thank all residents for their support and cooperation throughout this project. The City recognizes the impact this work may have on your daily routines and appreciates your understanding and patience throughout the project.
