

HURONIA ROAD AND MCKAY ROAD TRANSPORTATION IMPROVEMENTS & TRUNK SANITARY SEWER

START DATE: October 2025

END DATE: December 2027

Timeline is subject to change.

The City of Barrie (City) is undertaking major infrastructure improvements along Huronia Road and McKay Road East to support growth and strengthen critical services in the area. The project will include new sanitary sewers and watermains, full reconstruction of Huronia Road, resurfacing of McKay Road East, as well as intersection upgrades and major culvert crossings.

Utility relocation work is currently underway, and lane restrictions may be required during this phase. This is a multi-year project, with the first phase of construction scheduled to begin in October 2025.

This project represents a significant investment in the City's infrastructure and is aligned with Council's strategic direction to support planned growth and enhance services for residents. The work is included in City Council's approved 2025 budget. This project is funded in part by the Government of Ontario.

MAP OF THE WORK AREA












WORK DETAILS

On Huronia Road and McKay Road East, the Contractor will:

- Continue to coordinate utility relocations with various utilities.
- Install new sanitary sewers and watermains using micro-tunnelling technology.
- Carry out dewatering and by-pass pumping operations to allow work to proceed.
- Upgrade intersections at Huronia Road/McKay Road and Huronia Road/Lockhart Road.
- Replace culverts at watercourse crossings.
- Reconstruct sections of Huronia Road and resurface McKay Road East.

WHAT TO EXPECT DURING CONSTRUCTION

Huronia Rd & McKay Rd, including the intersections of Huronia/Lockhart and Huronia/McKay will be closed to through traffic during construction. **Access to residents' homes and businesses, as well as emergency service vehicles, will be maintained.** Closures will occur in stages as work progresses. Residents and businesses will be notified in advance of any road closures.

	<p>Precondition Surveys:</p> <p>The Contractor has retained the services of OZA Inspections Ltd.to complete a precondition survey of your home. Separate letters will be sent from the City and the survey company to book an appointment.</p>
	<p>Road and Sidewalk Access:</p> <p>During different stages of construction, certain sections of road will be closed to through traffic, with access to residences/business' being redirected. The City will post signage, as required, on how to access businesses.</p> <p>Access for emergency vehicles will always be maintained.</p>
	<p>Driveway Access:</p> <p>Vehicle entry to properties within the construction limits will be available. At times, direct access to driveways will be temporarily interrupted, in these cases individual notices will be delivered with additional information about the interruption.</p> <p>Services:</p> <p>Hydro, telephone, cable TV, and gas services should not be affected by the construction, barring any unforeseen circumstances.</p>
	<p>Accessibility:</p> <p>There is not an existing sidewalk within the project limit, but If you have any accessibility requirements, such as wheelchair access or home care, please contact the City representatives listed below.</p>
	<p>Traffic Management:</p> <p>The Contractor will use detour routes for traffic to reroute vehicles around the road closure.</p>
	<p>Transit Service:</p> <p>The proposed construction will not affect fixed Barrie Transit Routes, and Schedule but will impact Transit ON Demand Zone F. Changes to Transit ON Demand routes will be posted in advance on the City of Barrie website.</p>
	<p>Parking:</p> <p>Unless express permission is granted, Parking on roadways in an active construction area is not permitted. Vehicles parked in the construction zone will be ticketed and towed.</p>
	<p>Garbage and Recycling – City of Barrie and County of Simcoe:</p> <p>Garbage, recycling, and yard waste will be collected on the regular collection day during construction.</p> <p>The Contractor may need to move items to a designated area for pickup by the City's waste contractor. Garbage cans, organics bins, and recycling boxes will be returned to your property later the same day. Clearly mark your address on all containers.</p> <p>If curbside pickup service is available to you, please ensure all items are placed at the curb by 7:00 a.m. on the collection day, as late set outs may not be collected.</p>
	<p>Safety:</p> <p>The Contractor is required to conduct work in a safe manner, such as using traffic cones and fencing off excavations. Please use extra caution in the construction zone to ensure everyone's safety.</p>
