NOTICE OF THE FILING OF A COMPLETE APPLICATION AND PUBLIC MEETING PURSUANT TO SECTIONS 34(10.4), 34(12), 22(6.1) AND 17(15) OF THE PLANNING ACT, R.S.O. 1990, AS AMENDED, IN RESPECT TO A PROPOSED AMENDMENT TO THE OFFICIAL PLAN AND ZONING BY-LAW

Re: Application for an Official Plan Amendment and Zoning By-law Amendment
The Jones Consulting Group Ltd. on behalf of Global Telecom Inc., **501-525 Tiffin Street, Barrie**

TAKE NOTICE that the Corporation of the City of Barrie is in receipt of a complete application as of **Monday, January 19, 2026** for a proposed **Official Plan Amendment and Amendment to the Zoning By-law**.

TAKE NOTICE that the Affordability Committee of the Council of the Corporation of the City of Barrie will hold a public meeting on **Wednesday, March 25, 2026 at 6:00 p.m.** to review application submitted by The Jones Consulting Group Ltd., on behalf of Global Telecom Inc., for an Official Plan Amendment and Amendment to the Zoning By-law to permit the development of three (3) industrial buildings on lands described as Part Lots J, K, L on Plan 845 (Innisfil), being Part 1, on Plan 51R-7366, and known municipally as 501-525 Tiffin Street.

The site is approximately 7.23 hectares in size and located on the south side of Tiffin Street, east of the intersection with Dunlop Street West. The site is currently vacant and has approximately 207 metres of frontage along Tiffin Street.

The proposed Official Plan Amendment seeks to redesignate the lands from 'Natural Heritage System' to 'Employment Area – Industrial' and the proposed Zoning By-law Amendment seeks to rezone the lands from 'Environmental Protection Area' (EP) to 'General Industrial' (GI) to facilitate the development of three (3), single storey industrial buildings, one (1) being a multitenant building with seven (7) units, with a total combined GFA of 6,704 square metres and associated parking.

This public meeting will be held in a virtual forum with electronic participation and in person at City Hall. The meeting will be livestreamed on the City's YouTube Channel <http://youtube.com/citybarrie>.

If you would like to participate virtually, you will need access to a computer with internet service or a telephone. If you wish to provide oral comments at the public meeting, please register in advance by emailing: cityclerks@barrie.ca or calling 705-739-4220 x5500 during regular office hours prior to **March 25, 2026 by 12:00 p.m.** Once you register, you will be provided information from the Legislative Services Branch on how to make your submission.

Any person may attend the meeting and make representation or present submission respecting this matter. If you wish to make a written submission concerning this matter, please email or mail written comments to cityclerks@barrie.ca or City Hall, 70 Collier Street, PO Box 400, Barrie, ON L4M 4T5 (attention: City Clerk). Written comments must be received by **March 25, 2026 by 12:00 p.m.**

Notification of the approval of the Official Plan Amendment and Zoning By-law Amendment by the City will be provided upon written request to the undersigned file manager in the Development Services Department – Planning Division.

If a person or public body who would otherwise have an ability to appeal the decision of the Council of the City of Barrie to the Ontario Land Tribunal (OLT) but the person or public body does not make oral submissions at a public meeting or make written submissions to the Corporation of the City of Barrie in respect of the proposed Amendment to the Official Plan and Zoning By-law before the Corporation of the City of Barrie gives or refuses to give approval of the Amendment to the Official Plan and Zoning By-law:

- (a) the person or public body is not entitled to appeal the decision of the Corporation of The City of Barrie to the Ontario Land Tribunal (OLT); and
- (b) the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

All information including opinions, presentations, reports, documentation, etc. provided for or at the Public Meeting are considered public records. This information may be posted on the City of Barrie website and/or made available to the public upon request. Questions about this collection should be directed to the undersigned.

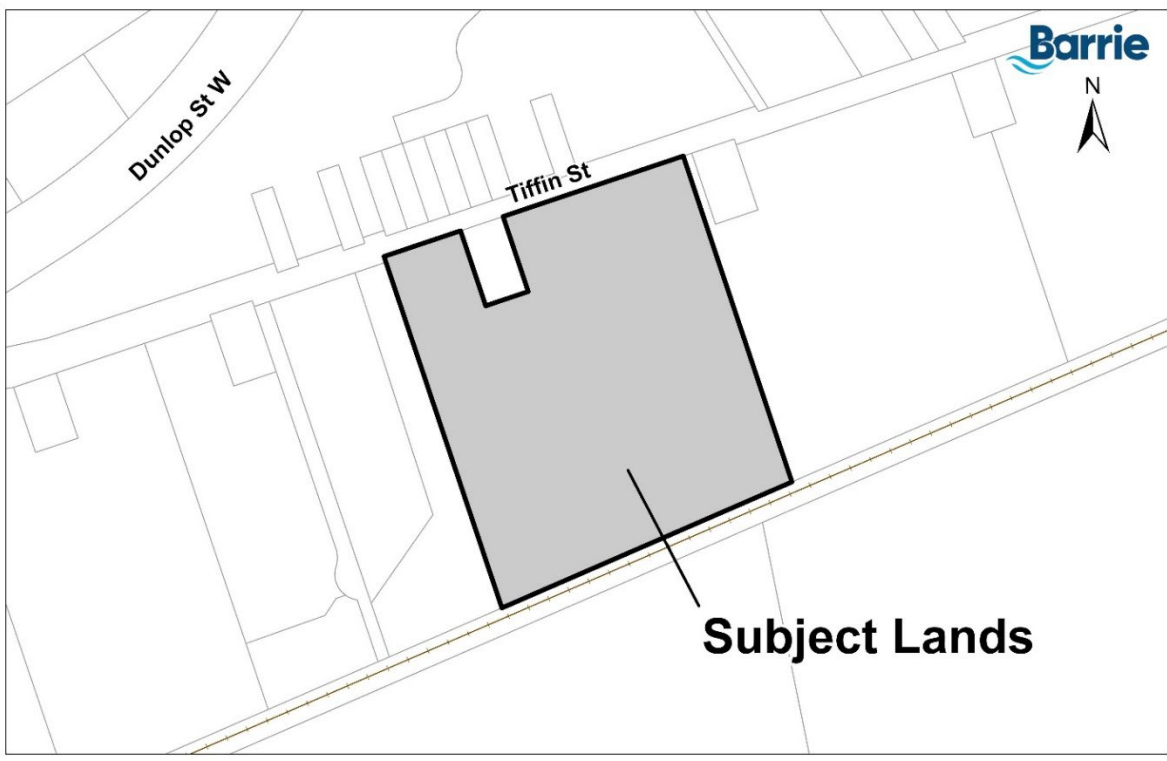
