

Notice of the Filing of a Complete Application and Notice of a Public Meeting in Respect to a Proposed Amendment to the Zoning By-Law Pursuant to Section 34(10.4) and 34(13) of the Planning Act, R.s.o. 1990, as Amended.

Re: Amendment to the Zoning By-law – Innovative Planning Solutions on behalf of Tonlu Holdings Ltd., 17 & 27 Jacob's Terrace – FILE REF. D30-013-2021

TAKE NOTICE that the Corporation of the City of Barrie is in receipt of a complete application as of Thursday, September 23, 2021 for a proposed **Amendment to the Zoning By-law.**

TAKE NOTICE that the Planning Committee of the Council of the Corporation of the City of Barrie will hold a public meeting on **Tuesday, November 23, 2021 at 7:00 p.m.** to review applications for an Amendment to the Zoning By-law submitted by Innovative Planning Solutions on behalf of Tonlu Holdings Ltd., for the lands located at 17 & 27 Jacob's Terrace, legally described as Plan 30 Lots 7, 8, 9 and Part Lots 5, 6 & 10, City of Barrie.

The application is intended to amend the current zoning from 'Light Industrial' (LI) to 'Transition Centre Commercial' with Special Provisions (C2-2)(SP-XXX) to facilitate the development of two residential towers, 24 and 26 storeys in height, with a total of 565 units. The special provisions include, but are not limited to, reducing the commercial use requirement to 0%, increase in height, and decreased setback from the railway.

The complete submission package is posted on the Proposed Developments webpage barrie.ca/ProposedDevelopments under **Ward 8.**

With the current restrictions on public gatherings due to COVID-19, this public meeting will be held in a virtual forum with electronic participation. It will be televised on Rogers TV and will be livestreamed on the City's YouTube Channel www.youtube.com/citybarrie.

To participate in the virtual planning meeting, you will need access to a computer with internet service or a telephone.

If you wish to make a written submission concerning this matter, it should be directed to Legislative and Court Services by Monday, November 22, 2021 by 12:00 p.m. Any person may make representation at the meeting however, written submissions and advance registration are encouraged.

Notification of the Amendment to the Zoning By-law if adopted by Council, will be provided upon written request to the undersigned file manager in the Development Services Department – Planning Division.

If a person or public body does not make oral submissions at the public meeting or make written submissions to the Corporation of The City of Barrie before the Amendment to the Zoning By-law is passed:

- (a) the person or public body is not entitled to appeal the decision of the Corporation of The City of Barrie to the Ontario Land Tribunal (OLT); and
- (b) the person or public body may not be added as a party to the hearing of an appeal before the OLT unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

All information including opinions, presentations, reports, documentation, etc. provided for or at a Public Meeting are considered public records.
