* 100% of the cost of downspout disconnection to a maximum of \$70 will be reimbursed: \$25 for the first downspout; \$15 each for subsequent downspouts.

* 100% of the cost of building permits will be reimbursed. You will require a copy of the final inspection certificate with City sign off.

* 75% of foundation drain disconnection, construction of sump and installation of pump with surface discharge to a maximum of \$2,000 will be reimbursed.

* 75% of the cost to cap the sanitary drain and install sump pump with surface discharge to a maximum of \$300 will be reimbursed. If a sump pit is required, the maximum rebate increases to \$675.
